## THE VENUE & SCOPE OF THE PROGRAMMES

## COURSE FEES & BANK DETAILS

The registration process can only commence with full payment of the fees as stated:

[1] For the **Associate Grade Programme** in Abuja, Nigeria, the fee is Five Hundred U.K Pounds Sterling [£500.00] or Seven Hundred and Fifty U.S Dollars [USD\$750.00] per person. And for the **Joint IDRI/UN Conference on DRDE** the fee is Six Hundred U.K Pounds Sterling [£600.00] or Nine Hundred and Fifty U.S Dollars [USD\$950.00] per person. If a participant is attending both progs. in Abuja, the fee is One Thousand U.K Pounds Sterling [£1,000.00] or One Thousand Five Hundred US Dollars [USD\$1,500].

[2] For participants who have completed the above **IDRI Associate Programme** and who wish to proceed to **Full Membership Grade International Programmes** in London, Istanbul, Amsterdam, Brussels or Vienna, the registration fee per person is Two Thousand Five Hundred U.K Pounds Sterling [£2,500.00] or Three Thousand Seven Hundred and Fifty U.S Dollars [USD\$3,750.00].

[3] For Full Membership Grade International Programmes in London, Istanbul, Amsterdam, Brussels or Vienna, the fee per person is Three Thousand U.K Pounds Sterling [£3,000.00] or Three Thousand Nine Hundred and Ninety U.S Dollars [USD\$3,990.00].
