[1] **For the Associate Grade Programmes in Lagos & Abuja, Nigeria**, the fees are Three Hundred And Seventy Five U.K Pounds Sterling [£375] per person or Five Hundred US Dollars [USD \$500] per person.

- [2] For participants, who have completed the above IDRI Associate Programmes and who wish to proceed to Full Membership Grade International Programmes in London, Washington DC and Paris. The fee per person is One Thousand Eight Hundred Eighty Five U.K. Pounds Sterling [£1,885], or Two Thousand Five Hundred US Dollars [USD\$ 2,500] and if they want to proceed to either of the programmes in Brussels, Cairo, Cape Town or Dubai the registration fee is One Thousand Two Hundred And Twenty Five UK Pounds Sterling [£1,225] or One Thousand Seven Hundred US Dollars [\$1,700]
